RESOLUTION AUTHORIZING THE WASHINGTON ISLAND SCHOOL DISTRICT SCHOOL DISTRICT BUDGET TO EXCEED REVENUE LIMIT FOR TWO YEARS FOR NON-RECURRING PURPOSES

WHEREAS, the School Board of the Washington Island School District, Door County, Wisconsin (the "District"), pursuant to Section 121.91(3) of the Wisconsin Statutes, has duly adopted an initial resolution entitled: "Initial Resolution" Authorizing the District to exceed the revenue limit imposed under Section 121.91(2m) of the Wisconsin Statutes on a non-recurring basis by \$935,000 in the 2023-2024 school year and by \$935,000 in the 2024-2025 school year for the purposes of paying the ongoing operational expenses of the school district; and

WHEREAS, the School Board has determined to submit the Initial Resolution directly to the electors of the District for approval or rejection at a referendum election pursuant to Section 121(3)(a) of the Wisconsin Statutes; and

WHEREAS, the Initial Resolution shall not be effective unless approved by a majority of the District electors voting at the referendum; now therefore

BE IT RESOLVED by the School Board of Washington Island School District, Door County, Wisconsin, that the revenues included in the Washington Island School District budget be authorized to exceed the revenue limit specified in Section 121.91(2m). Wisconsin Statutes. by \$935,000 for the 2023-2024 school year and by \$935,000 for the 2024-2025 school year for non-recurring purposes of paying the ongoing operational expenses of the school district.
