- 1. President Amy Jorgenson called the meeting to order at 6:34 p.m. Other board members present: Tom Jordan, Kevin Krueger, Sarah Duggan Goldstein, and Kirsten Purinton; Administrative Assistant: Sue Cornell; Teachers: Michelle Jordan; Community members: Hans Lux and Mike Kickbush.
- 2. MSP (Purinton/Jorgenson) to approve the agenda as presented. Approved 5-0.
- 3. **Open Session -** Board Clerk, Kirsten Purinton, explained the events and timeline that led to the posting of he Board Vacancy. The Board announced a vacancy on the Board of Education due to a clerical error in term length which resulted in the election term of Amy Jorgenson to be complete on midnight on April 22. The Board will nominate a candidate pursuant to the Board Vacancy Policy #133 to fill the board member spot until the next election in April 2019. Applicants need to submit a letter of interest and resume to the District office by noon on Friday, April 13. The current members of the Board of Education will convene in a posted, open meeting on Monday, April 16 at 6:00 p.m. to nominate and vote to fill the board position until the next spring election. Mike Kickbush responded that he hopes any person interested in being nominated to fill the board vacancy would not have a conflict of interest, because he feels this a big problem.

Approved 5-0. Tom Jordan left for the first half of the closed session.
