Statute on voting virtually at the annual meeting

Electors that are participating virtually will not be able to vote on any items unless the electors present in person make and pass a motion for virtual attendees to vote.

Most districts with virtual options do not allow virtual attendees to vote as there are potential difficulties associated with conducting the meeting, making motions, debating, voting, and challenging an elector's eligibility to vote under section 120.08(3) in a virtual setting.

120.08(3) (3) Challenge. If a person attempting to vote at an annual or special meeting is challenged, the chairperson of the meeting shall state to the person challenged the qualifications necessary to vote at the meeting. If such person declares that he or she is eligible to vote and if such challenge is not withdrawn, the chairperson shall administer the following oath or affirmation to him or her: "You do solemnly swear (or affirm) that you are an actual resident of this school district and that you are qualified, according to law, to vote at this meeting". A person taking such oath or affirmation shall be permitted to vote, but if that person refuses to take such oath or affirmation that person may not vote.

- 2. Election of Chairperson MSP (S. Sorensen/B. Wagner) to nominate Don Riewe to the position of meeting chairperson. Approved by a majority vote.
- **3. 2020 Annual Meeting minutes MSP (S. Sorensen/S. Cornell)** to approve the minutes of the 2020 annual meeting, as presented, without reading aloud. Approved by a majority vote.
- **4. Annual report The State of the District** Michelle Kanipes Principal/Curriculum Director presented the many accomplishments and highlights from the 2020-21 school year. She then shared the District growth plan for 2021-22. Then, Sue Cornell, Administrator of Business Services, gave the report on building updates during the 2020-21 school year.
- **5. Treasurer's report -** Sue Cornell, gave a review of the District's budget from the 2020-21 school year. Sara Sorenson presented the unaudited 2020-21 general fund revenues were \$1661,011.65, the expenditures were \$1,489,393.19. The difference of \$171,618.46 was added to the fund balance, resulting in a fund balance amount of \$879,685.11.
- 6. Proposed budget for 2021-2022 Sue Cornell and Sara Soresen presented the budget proposed for this school year. The proposed budget for the 2019-2020 fiscal year has an estimated Fund 10 total revenue of \$1,698,249. The estimated expenditures for the 2020-21 school year total \$1,853,116.00 with an estimated decrease in Fund Balance of \$154,867. Mrs.Sorenson proposed a total school tax levy of \$1,365,448.00 in order to finance the proposed school budget. The Washington Island School Board voted to exercise their right to not levy the non-recurring referendum limit total amount for one year only. The Washington Island School Board opted to reduce the non-recurring referendum amount approved by the taxpayers from \$675,000 to \$475,000 for the 2021-22 school year. This reduction in levy was possible because the District has maintained a healthy Fund Balance, received unbudgeted federal ESSR funds due to the COVID-19 pandemic, received declining enrollment aid, wrote and was awarded multiple grants, and had fewer expenditures in the spring of 2020 due to the state-wide school shutdown. The equalized land value for the Town of Washington increased by about \$30,000,000 from last year, and will result in a mill rate of \$4.18/\$1000 of assessed value for the upcoming tax year for the school district's portion of your tax bill. This is the lowest rate in five years. The Board would like to thank the Island community for supporting past operating referendums, and demonstrates the Board is working to be fiscally responsible with taxpayers dollars.

Now, therefore, be it resolved by the electors of the Washington Island School District, assembled at the annual district meeting on the 13th day of October as follows:
 - a. There be and there is hereby levied upon all the taxable property of the Washington Island School District for the year 2021-2022, a tax in the amount of one million, three hundred and sixty-five thousand, four hundred and forty-eight dollars (\$1,365,448), and the School District Clerk is hereby directed to extend said tax levy to the town affected in accordance with the proportionate valuation in the municipality at the time and in the manner provided by Wisconsin Law so said tax will be extended and collected by said Town in the same manner and at the same time as taxes for general Town purposes are extended and collected.
























GROWTH

Priority Area Score






English Language Arts Score: 100.0






ON-TRACK TO GRADUATION



Treasurers Report for the Annual Meeting

The unaudited 2021-22 general fund revenues were \$1,543,191.11; and the expenditures were \$1,533,942.40

The difference of \$9248.71 has been added to the district's Fund Balance resulting in a fund balance amount of \$888,933.82

The proposed budget for the 2022-2023 fiscal year has an estimated revenues of \$1,798,081 and estimated expenditures of \$1,798,081 with an estimated zero change in fund balance.

The district is proposing a total school tax levy of \$1,525,148 in order to finance the proposed school budget. This results in a mill rate of 4.04 /\$1000 of assessed value which is a decrease of \$.14 from the previous year.



Annual Meeting Resolution B - Furnishing Workbooks, Classroom Resources and Textbooks NOW, THEREFORE, BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 18th day of October, 2022 as follows: the School District will furnish, free of charge, all books, workbooks and classroom resources to all students for the 2022-2023 school year.

Annual Meeting Resolution C- Transportation of Students

RESOLUTION FOR PROVIDING FOR TRANSPORTATION OF STUDENTS BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 18th day of October 2022 as follows: Pursuant to Section 121.54(2)(c), Wis. Stats., the School District shall provide transportation to those pupils residing in the School District not otherwise required to be transported by Section 121.54, Wis. Stats., by hereby authorizing the School Board of said School District to transport, in its discretion, any student living less than two miles from the schoolhouse being attended by said student, with pick up points for students who reside between one and two miles from school during the 2022-23 school year. In exercising this discretion, said School Board is restricted by the requirements of reasonable uniformity in the minimum distance as provided for in Section 121.54(2)(c).

Annual Meeting Resolution D - Tax Levy

WHEREAS, a public hearing on the proposed budget for the year 2022-2023 school year, which provides specific sums for various items requiring or permitting a tax levy by the electors, has been held at this meeting: NOW, THEREFORE, BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 18th day of October, 2022 as follows:



There be and there is hereby levied upon all the taxable property of the Washington Island School District for the year 2022-2023 a tax in the amount of one million, five hundred and thirty-two thousand, four hundred and sixty dollars (\$1,525,148..00), and the School District Clerk is hereby directed to extend said tax levy to the town affected in accordance with the proportionate valuation in the municipality at the time and in the manner provided by Wisconsin Law so said tax will be extended and collected by said Town in the same manner and at the same time as taxes for general Town purposes are extended and collected.
- 2. It is hereby declared that the taxes hereby levied are for the purposes and for the combined aggregate amount provided in the 2022-2023 school budget aforementioned which budget after crediting the other estimated income required the above levy.


