- 1. Call to Order Vice President Mike Thielke called the meeting to order at 6:07 p.m.
- 2. Pledge of Allegiance
- 3. Election of Chairperson –MSP(Zuzka Krueger/Bob Wagner) to nominate Erica Sawasko to the position of meeting chairperson. MSP(S. Cornell/B. Wagner) to elect Erica Sawasko to the position of meeting chairperson. Approved by majority vote.
- **4.** MSP (Z. Krueger/M. Thielke) to approve the minutes of the 2021 annual meeting as presented, without reading aloud. Approved by majority vote.
- **5.** MSP (S. Cornell/M. Thielke) to allow virtual attendees to make motions and vote on video with hands raised. Approved by majority vote.
- 6. Annual report State of the District Tim Verboomen Principal/Curriculum Director presented the many accomplishments in academics and extracurriculars and highlights from the 2021-22 school year. He then shared the District growth plan for 2022-23. Then, Sue Cornell, Administrator of Business Services, gave a review of district building improvements during the 2021-22 school year and future projects for the 2022-23 school year. She then reviewed the district budget philosophy and reviewed the budgetary particulars of the district for the 2022-23 school year.
- 7. **Treasurer's report** Brett Goldstein gave a review of the District's budget from the 2022-23 school year. Mr. Goldstein presented the unaudited 2022-23 general fund revenues were \$1,543,191.11, and the expenditures were \$1,533,942.40. The difference of \$9248.71 was added to the fund balance, resulting in a fund balance amount of \$888.933.82. The proposed 2022-2023 Preliminary Budget is \$1,798,081.00 in revenue and \$1,798,081.00 and the expenditures with a proposed balanced budget, resulting in the Fund Balance remaining the same. The anticipated tax levy is \$1,532,460.00 with a mill rate of \$4.04 per \$1000 of assessed value of the home. The Washington Island new total assessed value increased to \$377,764,600.
- 8. Proposed budget for 2022-2023 –Sue Cornell presented the budget proposed for this school year. The district's proposed budget total gross Fund 10 expenditures for the 2022-23 school year are \$1,798,081.00. Proposed net total expenditures of all funds are \$1,915,782.00. This is an increase of 17.7 %. Mrs. Cornell proposed a General Levy fund of 1,525,148.00. Sue reminded the attendees that there are Esser funds (Covid 19 Federal monies) in parts of the budget. Proposed total revenue 1,798,081.00.
- 9. Hearing on the Budget A period of public comment will be held
- 10. Resolutions
- A. MSP (E. Sawasko/T. Verboomen) to approve the school board members will receive an annual salary of \$2400 (paid out in 12 equal installments on the 30th of every month). It is the intention that the annual salary covers all meetings of the school board. Brett Goldstein proposed the board

- no longer be paid for this position. Kirsten Purinton pointed out that there is an opportunity for board members to opt out of being paid, and would want board members to be able to be paid if there were lost wages that could be supplemented with this salary. Approved by a majority vote, with several board members abstaining.
- B. MSP (S. Cornell/B. Wagner) to approve that the school district will furnish, free of charge to students, all books, workbooks and classroom resources for the 2022-2023 school year. Approved by a majority vote.
- C. MSP (B. Wagner/M. Thielke) to approve that the school district will furnish free transportation, to and from school, for all pupils who reside two miles or more from school, with pick up points for students who reside between one and two miles from school during the 2022-2023 school year. (B. Wagner/ M. Thielke) to amend the previous motion to allow transportation of students who reside less than 2 miles from the school. Approved by a majority vote. Approved by a majority vote.
- D. MSP (T. Verboomen/B. Wagner) to adopt of tax levy for the 2022-2023 school year in order to finance the proposed school budget: Where as, a public hearing on the proposed budget for the year 2022-2023 school year, which provides specific sums for various items requiring or permitting a tax levy by the electors, has been held at this meeting. Now, therefore, be it resolved by the electors of the Washington Island School District, assembled at the annual district meeting on the 18th day of October as follows:
 - a. There be and there is hereby levied upon all the taxable property of the Washington Island School District for the year 2022-2023, a tax in the amount of one million, five hundred and twenty-five thousand, one hundred and forty-eight dollars (\$1,525,148), and the School District Clerk is hereby directed to extend said tax levy to the town affected in accordance with the proportionate valuation in the municipality at the time and in the manner provided by Wisconsin Law so said tax will be extended and collected by said Town in the same manner and at the same time as taxes for general Town purposes are extended and collected.
 - b. It is hereby declared that the taxes hereby levied are for the purposes and for the combined aggregate amount provided in the 2022-2023 school budget aforementioned which budget after crediting the other estimated income required the above levy. Approved by a majority vote.
- E. MSP (M. Thielke/B. Wagner) to set the date October 23, 2023 for the Annual Meeting time and grant board authority to change if necessary. Approved by a majority vote.
- 11. Other business pertinent to the annual meeting. None.
- 12. MSP (M. Thielke/B. Wagner) to adjourn 7:35 p.m. Approved by majority vote.

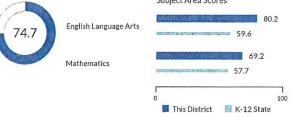

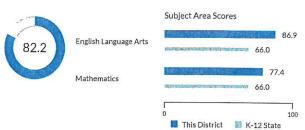

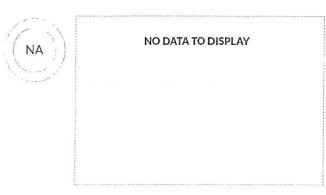




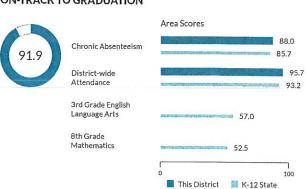

Priority Area Score

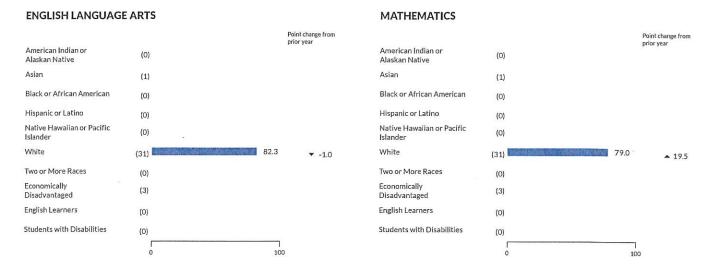


English Language Arts Score: 80.2 Mathematics Score: 69.2



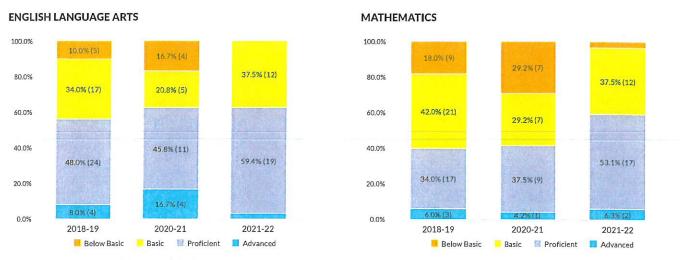
Student Group Achievement, 2021-22 (for information only)

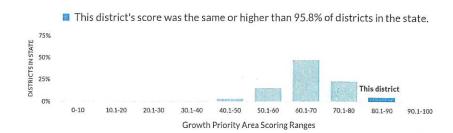
GROWTH

Treasurer's Report for the Annual Meeting

The unaudited 2022-23 general fund revenues were \$1,804,227.72; and the expenditures were \$1,819,756.92. The difference of \$15,529.20 has been subtracted from the district's Fund Balance resulting in a fund balance amount of \$873,405.28

The proposed budget for the 2023-2024 fiscal year has an estimated revenues of \$1,909,826 and estimated expenditures of \$1,909,826 with an estimated zero change in fund balance.

The district is proposing a total school tax levy of \$1,577,325 in order to finance the proposed school budget. This results in a mill rate of 3.50 /\$1000 of assessed value which lowers the mill rate by \$.54 from the previous year.

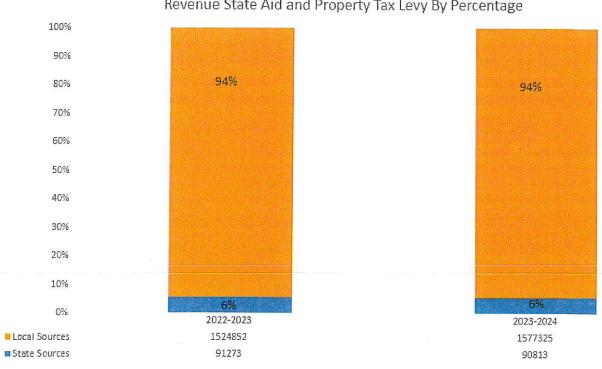

Annual Meeting Resolution B - Furnishing Workbooks, Classroom Resources and Textbooks RESOLUTION FOR THE PROVISION OF CLASSROOM RESOURCES BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 10th day of October, 2023 as follows: the School District will furnish, free of charge, all books; workbooks; and classroom resources to all students for the 2023-2024 school year.

Annual Meeting Resolution C- Transportation of Students

RESOLUTION FOR PROVIDING FOR TRANSPORTATION OF STUDENTS BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 10th day of October 2023 as follows: The School District will provide free transportation, to and from school, for all pupils who reside in the district, including those who reside less than two miles from the school during the 2023-2024 school year.

Annual Meeting Resolution D - Tax Levy

WHEREAS, a public hearing on the proposed budget for the year 2023-2024 school year, which provides specific sums for various items requiring or permitting a tax levy by the electors, has been held at this meeting: NOW, THEREFORE, BE IT RESOLVED by the electors of the Washington Island School District, assembled at the annual district meeting on the 10th day of October, 2023 as follows:

- 1. There be and there is hereby levied upon all the taxable property of the Washington Island School District for the year 2023-2024 a tax in the amount of one million, five hundred and seventy-seven thousand, three hundred and twenty five dollars (\$1,577,325.00), and the School District Clerk is hereby directed to extend said tax levy to the town affected in accordance with the proportionate valuation in the municipality at the time and in the manner provided by Wisconsin Law; so said tax will be extended and collected by said Town in the same manner and at the same time as taxes for general Town purposes are extended and collected.
- 2. It is hereby declared that the taxes hereby levied are for the purposes and for the combined aggregate amount provided in the 2023-2024 school budget aforementioned which budget after crediting the other estimated income required the above levy.
